Although these professionals are likely to be trustworthy, will my child be left alone with them?

How can I confirm their identity?

## Religious centres / places

This can be any type of place of worship such as:

- Church
- Mosaue
- Synagogue
- Temple.

#### Ask yourself...

Does the centre have a safeguarding policy or procedures?

How well do I know the leader and his / her background?

Although these professionals are likely to be trustworthy, will my child be left alone with them?

Is my child happy to tell me about what happens?

If you think a child is being abused or neglected, take action straight away. The longer the abuse or neglect goes on, the longer it will take for a child to recover.

The child could take part in lots of leisure activities such as:

- Scouts and Guides
- Cinema / bowling
- Sports clubs
- Music lessons
- Theatre and drama
- Outdoor pursuits
- Fishing.

Does the organisation have a safeguarding policy and procedure?

What checks have been made on employees and volunteers?

Will my child be supervised by a safe adult at all times?

## Education

#### This can include:

- Primary and secondary schools
- Residential schools
- Private tutors
- After school activities

- Midday supervisors
- Traffic crossing
  warden
- School bus or taxi driver / escort
- Alternative provision?

### \Lambda Ask yourself...

Does the organisation have a safeguarding policy and procedure?

Does it keep your child safe with good security?

What checks are carried out on staff and volunteers?

Is there an effective anti-bullying strategy?

Does the school always know who will collect your child?

Is your child happy to talk about what they are doing?
